I move to approve the contract for the group, Sixteen Candles, in the amount of \$5,750 to provide entertainment at the Taste of Orland Park on Friday, August 4, 2017 from 8:30 p.m. - 11:00 p.m.

**2016-0797 2017 Taste Entertainment - 7th Heaven**

The 2016 Taste of Orland Park enjoyed its largest attendance to date. A key component to attracting large crowds is the head-line bands performing each night. Bands in our price range which attract large crowds are in high demand and in short supply, often booking up a year or more in advance. 7th Heaven is a popular local group that was a big draw for the 2015 and 2016 Taste of Orland Park as the Saturday headline act from 8:30 p.m. - 11:00 p.m.

Therefore, staff recommends entering into a contract with 7th Heaven to perform at the 2017 Taste of Orland Park from 8:30 p.m. - 11:00 p.m. on Saturday, August 5, 2017 at a cost of \$6,000.

I move to approve the contract for the group, 7th Heaven, in the amount of \$6,000 to provide entertainment at the Taste of Orland Park on Saturday, August 5, 2017 from 8:30 p.m. - 11:00 p.m.

**2016-0853 Healthcare Equalizer for Non-Union and IBEW Employees.**

A \$750.00 healthcare equalizer for 72 eligible non-union and IBEW employees has been included in the FY2016 budget.

Staff recommends that this amount be paid in December 2016 to equalize the employee premium expense amongst employee groups.

This amount is less than previous years as the employee premium expense difference among employee groups has decreased.

### **2016-0789 Sportsplex Woodway Treadmill - Purchase Approval**

On November 16, 2015 staff presented the Sportsplex Market Segmentation to the Recreation Committee and provided copies of the report to the Board of Trustees. The report included a summary of the community and Sportsplex membership demographics, an overview of the Sportsplex facility amenities, a full inventory of the fitness center equipment including current conditions of each piece, an overview of the feedback gleaned from the past two Sportsplex customer surveys, financial data and Capital projects/purchases, and a recommendation for future improvements and investment based on feedback and analysis.

Staff reviewed the findings of the report with the committee which identified the Sportsplex as a high-quality; mid-tier fitness facility providing a range of equipment options that satisfies the diverse needs of members. While several tiers of equipment are offered, it is prudent to maintain a consistency by type in each tier to provide users with the desired familiarity. The 2014/15 equipment purchases were outlined in the report and noted that these purchases would be brought to the Recreation and Parks Committee for consideration in the coming months. The equipment recommendation that is being considered tonight is aligned with the goal of maintaining the position of Sportsplex in its market segment as described in the report.

I move to approve waiving the bid process for the purchase of two (2) Woodway treadmills from the manufacturer;

And

Approve the purchase of two (2) Woodway treadmills from the manufacturer, Woodway USA, Inc. as outlined in the amount of \$22,528.20.

**2016-0812 Build Orland FY 2017**

The 'Build Orland' program was instituted by the Village Board of Trustees in 2010. The goal of the program was to encourage new growth and development through the temporary reduction and deferral of permit and impact fees. In 2011 & 2012, the program was renewed but only for new residential projects. In summary, new residential projects received a 25% reduction on permit/impact fees and a 50% reduction on water tap fees. Additionally, projects were also allowed to defer the payment until final occupancy. Projects with pre-existing incentive/inducement agreements (i.e. sales tax sharing) were not eligible for the program. Additionally, projects with existing development/annexations agreements could only receive one 'discount' of fees, either those set by agreement or the Build Orland, whichever is greater.

From 2013 to now, the program was scaled back to only include the deferral of permit fees until final occupancy of the home. This decision was based upon the increased stability in the housing market and the number of new housing starts in the Village.

For FY 2017, staff still recommends the continuation of the Build Orland program to allow payment deferral of permit fees until final occupancy of the home.

I move to approve an extension of the 'Build Orland' program for the FY 2017 to allow the payment deferral of permit fees for new residential permits.

**2016-0823 GIS Agreement with Cook County - Resolution**

Cook County has a GIS database that is used for Orland Park's GIS program at no cost. Cook County does however require a resolution and agreement prior to use of this data.

I move to pass Resolution Number 1612, entitled: A RESOLUTION FOR ACCESS TO GEOGRAPHIC INFORMATION SYSTEM.

**2015-0516 Townhomes at Colette Highlands PUD - Development Agreement Authorization - Ordinance**

On December 28, 2015, the Village Board of Trustees approved a 60 unit development on the remaining 3.6 acres of the former Colette Highlands Condominiums property (northwest corner of Park Station Boulevard and Somer Glen Lane). This was done via special use permit for a planned unit development, including site plan and elevations review.

On January 18, 2016, the Village Board of Trustees approved the nine (9) lot subdivision for this project.

The development agreement for this project is finalized. This is now before the Village Board of Trustees for consideration of an ordinance authorizing the parties to sign the agreement.

I move to pass Ordinance Number 5142, entitled: AN ORDINANCE AUTHORIZING DEVELOPMENT AGREEMENT (TOWNHOMES AT COLETTE HIGHLANDS - 15608-15624 PARK STATION BOULEVARD)

**2016-0783 Twin Towers Chapel Painting - Appearance Improvement Grant**

The purpose of this petition to obtain \$1,387.50 in funding assistance to re-paint the south and west elevations of the Twin Towers Sanctuary located at 9967 West 144th Street. In addition, some minor maintenance work and the repair or replacement of damaged trim and siding will be completed as needed. The building is listed on the National Register of Historic Places and is considered a contributing structure to the Old Orland Historic District and an Orland Park Landmark.

I move to authorize the Village President to execute the Appearance Improvement Grant Agreement for 9967 W. 144th Street.

I move to approve the Appearance Improvement Grant application for \$1,387.50 from account 010-0000-484930 for 9967 W. 144th Street, subject to the following conditions:

- 1) Obtain any required building permits from the Village's Building Department prior to initiating work.
- 2) Meet all final engineering and building code related items.
- 3) Match the proposed paint colors to the existing paint colors of the siding and trim.
- 4) Complete all project components and conditions of approval as detailed in Certificate of Appropriateness 2016-0671. No payout of AIG funds shall be issued without 100% completion of these conditions or requirements detailed in Certificate of Appropriateness 2016-0671.
- 5) Enter into an Appearance Improvement Grant Agreement with the Village of Orland Park.

And

Approve the Scaccia Decorating Co. bid for \$2,775 as the lowest bid for re-painting the south and west elevations of the Twin Towers Sanctuary at 9967 W. 144th Street and completing complete minor maintenance work as needed.

**2016-0737 Professional Engineering Services with Christopher B. Burke - Approval**

The Village of Orland Park's current contract with Christopher B. Burke Engineering, Ltd. (CBBEL) to provide professional engineering services expires December 31, 2016. Previous contracts for general engineering to be provided by CBBEL included a monthly retainer of \$8,500. Staff is recommending to approve the same amount for FY 2017.

Throughout the 2016 fiscal year, CBBEL has provided a variety of services working not only with Development Services, but also the Public Works and Parks Departments and the Village Manager's Office. The scope includes attending Village meetings, investigation of engineering matters, review of drainage complaints, and follow-up with developers and residents. CBBEL also serves as the Village's Professional Engineer (PE) for the review and approval of private development projects within the Village of Orland Park. The fees for this service are passed through to the developer for payment, and are billed at CBBEL's 2010 rates, which is a significant savings to our local developers.

I move to approve Professional Engineering Services Contract with Christopher B. Burke Engineering, Ltd. in the amount of \$102,000 (\$8,500 per month) as outlined in the proposal.

**2016-0788 Aquatic Weed Control - Bid 16-031 Award**

There are a total of 76 wet ponds totaling 128 acres that are the responsibility of the Village to maintain. Included in this maintenance is the management of aquatic weeds that occur naturally on the ponds.

A bid request for Aquatic Weed Control services for calendar years 2017, 2018 and 2019 was issued on October 11, 2016.

The bid specifications were separated into two categories. Twenty five (25) Schedule "A" ponds were proposed and quoted to receive regularly scheduled periodic treatments. Fifty (50) Schedule "B" ponds were cited in the bid specifications to receive treatments only upon request. The pricing for "Schedule B" ponds are on a per acre basis for algae control and a per acre basis for weed control. The treatment for schedule "B" ponds is strongly influenced by temperature, rainfall and run-off from the surrounding landscape.

Three (3) bid packages were received and opened by the Village Clerk's office on Tuesday October 25, 2016 at 11:00am. The following bids were recorded:

--Clark Aquatic Services (2017- \$30,161.00) (2018- \$30,613.42)  
(2019- \$31,072.62);

--Marine Biochemist (2017- \$28,975.00) (2018- \$29,775.00) (2019- \$30,550.00);



--Integrated Lakes Management (2017- \$23,410.80) (2018- \$23,410.80)  
(2019- \$24,581.34)

Staff has reviewed the proposals and the lowest bidder is the Village's current vendor, Integrated Lakes Management. The vendor has been responsive in the duties during the current contract and make themselves available to meet with residents to explain and address concerns they may have.

Staff recommends that the lowest bid from Integrated Lake Management of Waukegan, IL be accepted and that they be awarded the contract for the treatment of aquatic weeds for "Schedule A" and "Schedule B" services for a three year period (2017, 2018, and 2019).

I move to approve a three year contract with Integrated Lakes Management of Waukegan, IL for Aquatic weed control for a total amount not to exceed \$27,300 for budget year 2017, and an amount not to exceed Board approved funding for Fiscal years 2018 and 2019.

#### **2016-0234 New Walter Residence Old Orland Public Land Impact Assessment**

The petitioner is proposing to construct a new single family home in the Old Orland Historic District at 14420 First Avenue. The Certificate of Appropriateness is not complete for this project since there is a policy question regarding the use of park land at 14438 First Avenue for displaced depressional storage volume from private property.

The development of 14420 First Avenue will likely require variances related to setbacks as a result of the depressional storage issue (no matter how this is resolved). The variances are not part of the policy discussion before the Board of Trustees at this time. The project will return for a discussion about those variances at a future date.

In short, based on the assessment provided by CBBEL, staff cannot recommend approval of the proposed plan to relocate a portion of the petitioner's depressional storage (detention) to the Village-owned park property.

Staff is recommending that this request be denied.

Trustee Fenton requested that this item be continued until the December 19, 2016 Board of Trustees meeting.

I move to continue this item to the December 19, 2016 Board of Trustees meeting.

Interim Village Manager McCarthy reported that there were six budget hearings along with several other meetings between staff and the Board over the past few months.

President McLaughlin stated that this is the sixth year in a row that the Board is not raising the tax levy and the budget being presented tonight is balanced. The Village is able to fund a lot of work in the Village, including upgrading the Palos Fitness Center that the Village is in the process of taking over.

Trustee Ruzich reported that the total budget is \$139 Million with approximately \$24 Million in infrastructure improvements. The tax levy is flat and the Board has not increased or added any new taxes. The Board is very proud to present this balanced budget for hearing tonight.

### 2016-0830 2017 PACE Agreement - Ordinance

Annually, there is a need for the adoption of an ordinance authorizing the Village of Orland Park, Illinois, to execute the annual Paratransit Service Provider Agreement with the Suburban Bus Division of the Regional Transportation Authority (PACE).

This agreement is always reviewed by the Village Attorney for acceptability prior to an ordinance recommendation being brought forth for Village Board consideration. The agreement is prepared annually by PACE and sent to the Village for review and ordinance adoption that authorizes signing the agreement as called out in the ordinance.

Over the past few years, the agreement has arrived closer to the required ordinance adoption date necessitating last minute actions in order to meet meeting and agenda posting requirements and avoid PACE service interruptions. As a result, this agenda item is being considered by the Public Works Committee and the Village Board of Trustees on the same night.

## FINANCE

### 2016-0747 Fiscal Year 2017 Annual Budget Approval - Ordinance

After setting aside the appropriate amount of reserves as per Board approved fund balance policies, the Fiscal Year 2017 Annual Budget provides for a balanced budget, meaning that available sources are sufficient to fund projected operating and capital expenditures. Available sources consist of budget savings or operating surplus from prior year, capital funding reserves, and revenues projected for Fiscal Year 2017. The proposed Fiscal Year 2017 Annual Budget commencing on January 1, 2017 and ending on December 31, 2017 reflects approximately \$139,517,447 in revenues and \$147,419,118 in expenditures. The variance between FY2017 revenues and FY2017 expenditures is funded by prior year operating surplus and capital funding reserves.

The Fiscal Year 2017 Annual Budget was drafted through a series of budget workshops with the Village Board and departmental staff. The budget document was made available for public inspection on November 17, 2016. A public hearing on the Fiscal Year 2017 Annual Budget will be held on December 5, 2015.

### **2016-0790 2016 Property Tax Levy - Ordinance**

Presented is the proposed 2016 property tax levy for the Village of Orland Park, as well as the Orland Park Public Library. The total Village levy equals \$13,425,519 and includes the following individual line items, as reflected in the FY2017 Annual Budget approved by the Village Board on December 5, 2016.

Corporate - \$724,697  
Recreation & Parks - \$964,058  
FICA - \$1,661,132  
IMRF - \$2,066,038  
Police Pension - \$3,158,694  
Debt Service - \$4,850,900

The overall dollar amount of the Village's 2016 levy is equal to the 2015 levy. The operating levy increased by approximately \$12,175. Pension levies (FICA, IMRF and Police Pension) increased by \$593,465; the recreation levy decreased by \$50,377 and the Corporate levy, which funds public safety salaries, decreased by \$530,913.

The overall increase in the operating levy is offset by an decrease in the Debt Service levy by the same amount. The 2016 levy reflects abatements in the amount of approximately \$4,004,400 as Home Rule Sales Tax and Water & Sewer Fund user charges are utilized by fund debt service payments on a number of outstanding bond issues.

The total 2016 Orland Park Public Library levy equals \$6,827,627, including \$5,144,234 for operating purposes and \$1,683,393 for the payment of debt service on the library building bonds.

From tax year 2000 to 2009, the Village's equalized assessed valuation (EAV) grew an average of approximately 9.6% per year. Beginning in tax year 2010 and continuing through tax year 2015, the Village's EAV has declined approximately 30%. Although the total dollar amount of the Village's levy has not increased since tax year 2011, meaning that the Village's overall tax burden has not changed, the continued decline in the EAV causes the Village's tax rate to increase.

The Village's 2015 actual Cook County tax rate and estimated 2016 tax rate is

In the fall of 2011, the Village of Orland Park joined in a lawsuit filed by the RTA, Cook County, and a number of suburban municipalities against the City of Kankakee and the Village of Channahon ("Municipal Defendants"), a number of sales tax broker entities ("Broker Defendants"), and retailers, claiming that the defendants had conspired to improperly source sales of goods outside of the plaintiffs' jurisdictions to avoid local and regional sales taxes.

The RTA and its co-plaintiffs, including the Village have come to settlement terms with the Municipal Defendants and Inspired Development, LLC and Ryan, LLC, two of the Broker Defendants, which would release those Broker Defendants and

settle claims with regard to approximately \$860,000 in funds being held in escrow by the Municipal Defendants. The proposed settlement will not end the Litigation but will facilitate the resolution of claims with the remaining defendants.

**2016-0850 Partial Settlement Agreement and Release in RTA, et al. vs. City of Kankakee Litigation - Approval**

In the fall of 2011, the Village of Orland Park joined in the lawsuit filed by the RTA, Cook County, and a number of suburban municipalities against the City of Kankakee and the Village of Channahon ("Municipal Defendants"), a number of sales tax broker entities ("Broker Defendants"), and retailers, claiming that the defendants had conspired to improperly source sales of goods outside of the plaintiffs' jurisdictions to avoid local and regional sales taxes. The Village of Orland Park is a co-plaintiff in this lawsuit, which is being managed and directed by the RTA in consultation with the co-plaintiffs. The basis of the complaint is centered on Section 8-11-21 of the Illinois Municipal Code which allows local governments to recover tax revenue that was improperly sourced as a result of illegal sales tax agreements entered into after June 1, 2004.

Proposed Partial Settlement: At the encouragement of the Court, the RTA entered into settlement discussions with various groups of defendants and has come to tentative settlement terms with the Municipal Defendants and Inspired Development, LLC and Ryan, LLC, two of the Broker Defendants, which would release those Broker Defendants and settle claims with regard to approximately \$860,000 in funds being held in escrow by the Municipal Defendants. This agreement would not end the lawsuit, but it will simplify the case going forward.

The key terms of the Settlement Agreement are as follows:

---1) A cash settlement of \$450,000 for the co-plaintiffs to be drawn from the funds being escrowed by the Municipal Defendants that the Inspired and Ryan Broker Defendants assert claims on. This constitutes a recovery of approximately of \$0.50 on the dollar of sales tax revenue that the co-plaintiffs assert was improperly sourced in cooperation with the Inspired and Ryan Broker Defendants.

---2) Full release of the Inspired and Ryan Broker Defendants and a partial release of the Municipal Defendants with regard to their liability for funds associated with the Inspired- and Ryan-brokered economic development agreements (“EDAs”).

The Village of Orland Park will receive a portion of this cash settlement only if the RTA determines that the funds came from a retailer within Orland Park’s jurisdiction that improperly sourced sales tax revenue via Ryan- or Inspired-negotiated EDAs.

Although this is a settlement of claims against some of the defendants in this case, the execution of the Settlement Agreement does not foreclose the possibility of recovery of funds from the remaining defendants, whether by judgment or a separate, global settlement.

Staff has discussed this proposal with the Village Attorneys, and together have concluded that this settlement is advisable. Therefore, we recommend that the Village approve the proposed Settlement Agreement and Release.
