## ADDENDUM A TO SUPERVISORY CONTROL AND DATA ACQUISITION (SCADA) SUPPORT SERVICES DATED DECEMBER 16, 2024, BETWEEN

- 4. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
- 5. This Addendum A may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.
