RE: Amend Staging Requirements

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. In **SECTION 2: SCOPE OF THE WORK AND PAYMENT:** of said Agreement, the sentence “To provide and operate sound, stage and lighting for the taste of Orland Park for 2011 (optionally renew for 2012 and 2013), as described in the Sound Works Productions proposal dated 3/7/2011” shall be stricken and replaced with the following sentence “To provide and operate sound, stage and lighting for the taste of Orland Park for 2011 (optionally renew for 2012 and 2013), as described in the Sound Works Productions proposal dated 3/7/2011 and as amended per the email dated March 14, 2012 recommending Option 2 (Stage Line SL100) at a cost of \$3450 (\$1050 over original contract price).”
3. In **SECTION 2: SCOPE OF THE WORK AND PAYMENT:** of said Agreement, the sentence “An amount not to exceed Nine Thousand Five Hundred Fifty and No/100 (\$9,550.00) Dollars” shall be stricken in its entirety and replaced with:

“2011: an amount not to exceed Nine Thousand Five Hundred Fifty and No/100 (\$9,550.00) Dollars

2012-13: an amount not to exceed Ten Thousand Six Hundred and No/100 (\$10,600.00) Dollars”

4. All of the other terms, covenants, representations and conditions of said Agreement, not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
5. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the **25th day of April, 2012**, shall be attached to and form a part of the Agreement dated the 16<sup>th</sup> day of May, 2011 and shall take effect upon signature below by duly authorized agents of both parties.


