THE FOLLOWING PERTAINS TO OUR PROPOSAL:

Work to be completed by 11/15/2026

1. Furnish a complete door assessment for repairs or replacement.
2. Furnish and install new top and bottom pivot bearings.
3. Furnish and install approximately 200' of exposed conduit/wiremold and wire to existing electrical panel.
4. Furnish and install (2) 20A 120V circuit for door operators.
5. Furnish and install (2) dual door push auto operators required.
6. Furnish and install (4) activation paddle switches.
7. Furnish and install (2) stainless paddle switch stand.
8. Furnish and install additional controls and wiring for MAG Lock operation.
9. Furnish and install additional controls and wiring to incorporate security system to openers.
10. \$10,000.00 contingency included.
11. Repair drywall and patch, prime and paint around door area.
12. All work performed during normal working hours.
13. Work due to concealed conditions not included.

Note: It is unknown at this time if there are additional damaged door parts that may be required at the time of operators' installation.
