

WHEREAS, on September 8, 2016, a certain Agreement regarding Tree Purchase & Planting 2016 between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on April 21, 2017, a certain Agreement regarding Tree Purchase & Planting 2016 between the Village and the Contractor was amended (hereinafter referred to as the "Addendum A"); and

WHEREAS, the Village wishes to modify the Scope of Work.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.

1. **SECTION 1: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include "Addendum B dated May 12, 2017" and to include "Proposal dated April 10, 2017."
2. **SECTION 2: GOODS TO BE PURCHASED, COST AND DELIVERY, SCOPE OF THE WORK AND PAYMENT** of said Agreement shall be amended to include the following: "Furnish and install twenty (20) 4" Autumn Blaze, including initial watering and mulch in the amount of Twelve Thousand Five Hundred and No/100 (\$12,500.00) Dollars (\$625 each)."


