2018-0475 Harris Enterprise Resource Planning - Annual Software Maintenance

The Harris ERP/Innoprise software consists of core financials and payroll, utility billing, building permits, business licenses, code enforcement and online bill pay for utility billing.

Contractually, there has been no increase in maintenance fees for years 2012 through 2017. Maintenance fees have increased 4% for 2018.

2018-0500 Reciprocal Reporting System Intergovernmental Agreement Between the Village of Orland Park and the Board of Education of Orland School District 135 - Agreement

The Police Department is seeking to update the Intergovernmental Agreement with Board of Education of Orland School District 135 on an established reciprocal reporting system to enhance cooperation and maintain compliance with current Illinois Compiled Statutes including the Illinois School Code, Illinois School Records Act, the Juvenile Court Act and the Intergovernmental Cooperation Act.

2018-0512 Amend the Arena Americas Contract for the 2018 Taste of Orland Park - Approval

A three-year contract with Arena Americas to provide tents and equipment for the Taste of Orland Park event in 2016, 2017, and 2018 was approved by the Board of Trustees on April 4, 2016.

The 2018 contract amount was set at \$20,476. Additional expenses have resulted from an increase in the number of restaurants from 19 to 22, the addition of a VIP tent and accessories for the presenting sponsors, Palos Health and Loyola Medicine, and new entry barricades to aide in the inspection of bags at the entry gates. The current projected expense is estimated to be \$21,937.56. Additional expenses may occur during the execution of the event.

2018-0430 Laserfiche Electronic Document Management Software

As the Village looks to digitalize our paper-based environment, RFP #18-009 was published to search for a local vendor for assistance with software license and annual maintenance procurement, set-up and configuration, and staff training expertise. The ability to digitalize multiple different formats into an electronic searchable platform will improve staff productivity and help consolidate the volume of paper. The platform will be scalable and meet future needs around e-forms and workflows, electronic signatures and integration with existing enterprise systems - HRIS, Tyler Technologies, and Innoprise.

In total, there were three respondents, all preferred partners with Laserfiche, that delivered their offering. These are listed in alphabetical order by the primary responder: Accelerated Information Systems (AIS) of Hicksville NY, Proven IT of Tinley Park IL, and TKB Associates of Mokena IL. Staff ranked the vendors on the following: Locality, CJIS Certified, Years in Service, Municipal Governments, Police/Public Safety client base and references.

The RFP process highlighted many High Performing Organization objectives, which would enable staff to have the capability to electronically search for recently scanned documents coming from any format (microfiche, plats of survey, architectural drawings, file shares) and reduce the need to physically search between multiple areas within the Village. The system would also allow for integration with other platforms performing screen scrapes to search hot fields from an indexed and OCR SQL platform, allowing for a more efficient and timely use of the employees' time and Village resources.

2018-0550 Stellwagen Landscape Restoration Contract Adjustment

On April 16, 2018, the Village Board of Trustees approved the selection of Cardno, Inc. for landscape restoration at Stellwagen Farm as outlined in Request for Proposals (RFP #18-019 Stellwagen Family Farm Landscape Restoration). The Village subsequently established a contract with Cardno, Inc. to complete the Stellwagen Family Farm Landscape Restoration Project for an amount not to exceed \$112,220.00.

As noted in the original RFP approval request (Legistar # 2018-0227), the Cardno Inc. proposal for this project was \$12,780.00 below the \$125,000.00 budget approved by the Open Lands Commission. This \$12,780.00 balance, in addition to the remaining balance from the Stellwagen Perimeter Path project (\$31,188.00), is to be used for additional landscape restoration expenses, including landscape consultant, site amenity and signage costs as well as contingency funds for future site maintenance. Two (2) small projects outside of the original scope of work of the Cardno, Inc. contract have been identified by the Village since work began on the project in June, 2018. These two (2) projects include the installation of erosion control blanket over a section of prairie that is holding water and the seeding of a small area near the northwest section of the site.

As Cardno Inc. is already mobilized at the Farm and familiar with these issues, this request is to adjust the original contract for the Stellwagen Family Farm Landscape Restoration Project by \$7,000.00, or for an amount not to exceed \$119,220.00. This amount will cover the currently identified small projects (\$4,100.00) with a small contingency (\$2,900.00) allocated for any future work. The remaining overall project balance will be used for additional landscape restoration expenses, including landscape consultant, signage fees, and site amenities such as benches as well as contingency funds for future site maintenance. Any adjustment to the Cardno Inc. contract in the future to cover additional years of maintenance would require a separate Board approval.
