ADDENDUM A TO ECOLOGICAL RESTORATION SERVICES MASTER AGREEMENT, DATED APRIL 1, 2020, BETWEEN THE VILLAGE OF ORLAND PARK AND CARDNO, INC.

WHEREAS, on April 1, 2020, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and Cardno, Inc. (hereinafter referred to as "Contractor") for the performance of certain professional services for the Village in connection with Ecological Restoration Services Master Agreement (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify **CONTRACT DOCUMENTS**.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 1: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum A, dated December 12, 2022; and strike the Contractor's Name "Cardno, Inc." and replace with "Stantec Consulting Services, Inc." hereinafter referred to collectively as the "CONTRACTOR".
3. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
4. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the **12th day on December, 2022**, shall be attached to and form a part of the Agreement dated the 1st day of April, 2020, and shall take effect upon signature below by duly authorized agents of both parties.
