*8-1 1/2" Cement Eyebolts/Anchors Spaced 10' apart must be in place by Wed., 7/31/24 7am to Secure 4-20' x 20' Restaurant Tents.

Tents to be evacuated if winds exceed 25mph.

Indestructo Rental Company will not move any items that do not belong to us.

It is understood Indestructo Rental Company will not be responsible for any damage to grass/trees/paths during transport/use/removal.
