6. Furnish and install (24) 2x2 flat panels.
7. Furnish and install (97) 4' strip lights.
8. Furnish and install (9) exit signs.
9. Furnish and install (10) combo exit signs.
10. Furnish and install (39) dual tech occupancy sensors.
11. Furnish and install (5) emergency can drivers.
12. Remove existing (14) 4'x4' recessed round fluorescent fixtures.
13. Frame , drywall and tape ceilings for (14) removed round fixtures.
14. Paint ceilings in affected areas of (14) removed round fixtures.
15. Furnish and install (14) Recessed 4' LED strip fixtures.
16. Add conduit, wire and junction box with additional fixture whip to fixtures that are daisy chained together throughout building.
