Painting Options 1 and 2 and details

Grade 1 , Clean and Repaint - \$ 935.00

- Grind away bubble rust and remove old markings / decals

- Grind and clean roof area
- Mask off rubber door gaskets
- Air pressure loose dirt and dust on exterior after grinding
- Primer complete exterior
- Paint complete exterior with one coat of DTM paint (direct to metal by Sherwin Williams)

Grade 2 , Clean and Repaint - \$ 815.00

- Grind away bubble rust and peeling decal areas
- Air pressure loose dirt and dust on exterior after grinding
- Mask off rubber door gaskets
- Spot Primer large exposed areas
- Paint all exterior sides and a 1' extended area on the roof with DTM paint
- Touch up as needed

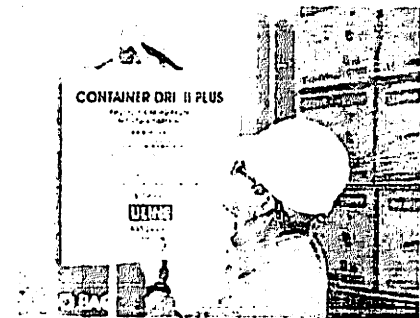

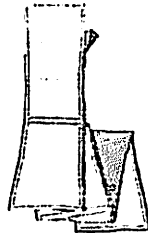
