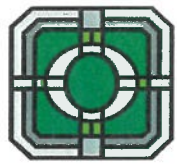

Q19	Question: Item #9 Apprenticeship and Training Program Will the Village of Orland Park reconsider Item #9 Participation in Apprenticeship and Training Program Requirements? The quantity of five (5) apprentices in each craft in the preceding five (5) years is onerous and exclusive, and limits qualified local small businesses from participating in this procurement. Would the Village of Orland Park consider participation in an apprenticeship and training program be enough, without specific quantification of numbers of personnel and years? This specific quantified number acts as a disqualifier and limits competition for the procurement. Qualified contractors participating in USDOL apprenticeship programs should be enough of a threshold for the Village of Orland Park. Participating companies that are signatory to local unions and current federal contractors have proven records of fair pay and certified payrolls. Retaining the threshold of five (5) apprentices per craft is diminishing the fairness of this procurement. Answer: Please refer to the Terms and Conditions document as it states that Section 1-16-7(D) of the Village of Orland Park's Village Code requires that the following be demonstrated, amongst other criteria, for a bidder to be considered "responsible": "(5) Participation in apprenticeship and training programs approved and registered with the United States Department of Labor's Bureau of Apprenticeship and Training or the Illinois Department of Labor, including the graduation of at least five (5) apprentices in each of the applicable construction crafts in the preceding five (5) years;" Section 1-16-7(D)(5) requires that the bidder evidence that the approved and registered PROGRAM in which it participates has graduated at least five apprentices in the preceding five years.	10/16/2025

Addendum #5 (10/22/2025)

Q: There are several construction access points shown. Some of those locations show utilities. Do we have to have protection pads over the lines, or will we be able to run loaded semis over them? If we have to have construction access pads, will you make an allowance as this will be difficult to determine the cost at bid time?

A1: We are coordinating with Nicor to get an answer to this question for exact requirements they may have and will be sent in a future addendum or shared with the selected contractor.

A2: Nicor Engineering has confirmed that no additional protection measures will be needed on this project, but it is required that when work is being completed in close proximity to Nicor’s existing facilities, Nicor Watch & Protect be contacted.

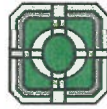

ADDENDUM #10 – Clarifications to Bid Documents

ITB #25-049 - Tinley Creek Bank Stabilization, Construction

This Addendum provides the following clarifications to the bid documents:

1. Lump Sum Bid

*The requested bid is a **Lump Sum** bid. Although the Special Provisions include a Basis of Payment with measurements for each pay item listed in the Summary of Quantities (SOQ), these quantities are for tracking construction progress only and **will not be used for payment**.*

*Unit rates are requested **only** for potential changes to the scope of work resulting from unforeseen conditions.*

2. Correction to Stone Toe Stabilization Quantity

*The total length of stone toe stabilization shown in the SOQ is incorrect. The estimated correct length is **8,045 linear feet (LF)**.*

3. Contractor's Responsibility for Quantities

*Contractors are responsible for preparing their own quantities for the project. The SOQ provided by the Village is for **guidance only** and must **not** be used as the sole basis for developing bid prices.*

4. Site Access Information

The following clarifications apply to site access locations:

- **Wheeler Road (Southwest Corner):** Property owned by the Village of Orland Park; no easement was required, and this location may be used for site access.
- **86th Street (Northeast Corner):** No additional temporary easements were granted beyond the permanent easement.
- **86th Street (Southeast Corner):** No additional temporary easements were granted beyond the permanent easement.
- **Orlan Brook Drive (West Side of Creek):** The gabion work abuts the public right-of-way; no additional access or temporary construction easements were granted beyond those shown on the plans.
- **Crystal Creek Drive (Either Side):** No additional access or temporary construction easements were granted beyond those shown on the plans.

OVERVIEW

The Village of Orland Park ("Village") is requesting bids for Tinley Creek Streambank Stabilization, Construction ("Project"). The Contractor shall furnish all labor, materials, equipment, and incidentals necessary to stabilize eroded sections along both sides of the creek. The work to be performed by the successful proposer shall be substantially complete by December 31, 2026, and 100% complete by August 31, 2027. Work includes:

- Installation of gabion walls
- Stone toe protection and stone bank armoring
- Slope grading and restoration
- Selective tree removals
- All collateral and incidental work required to complete the improvements in accordance with the attached plans, specifications, and special conditions

Funding and Compliance Requirements

This project is jointly funded by a grant from the Metropolitan Water Reclamation District of Greater Chicago (MWRD) and by local funds from the Village of Orland Park.

- **MWRD Grant Portion:** MWRD will provide **\$3.70 million** toward the project. All work funded by this amount must fully comply with **all MWRD requirements**, including participation goals for **Minority Business Enterprises (MBE), Women-owned Business Enterprises (WBE), Small Business Enterprises (SBE), and Veteran-owned Small Business enterprises ("VBE")**. Specific participation goals are detailed in the intergovernmental agreement (IGA) between the Village and MWRD, attached as Exhibit C. Bidders are responsible for familiarizing themselves with and complying with all applicable provisions of the IGA.
- **MBE Reporting:** If MBE goals are only partially met, proposers must specify the percentage achieved for each MBE category.
- **Village-Funded Portion:** Any portion of the bid **exceeding the \$3.70 million grant** must comply with all **Village of Orland Park requirements**.

Payment

- **Invoices:** All payment invoices will be submitted to and paid for by the **Village of Orland Park**

SUBMISSION DEADLINE

Bids must be submitted **no later than 11:00 a.m., local time, on November 13, 2025**. No consideration will be given to bids received after the stated date and time. Bids submitted must include all information and documents as requested in this Invitation to Bid. No oral or electronic bids sent by facsimile or via email will be accepted or considered. All bids received after the submittal deadline will be rejected and returned unopened. Failure to follow these instructions may result in rejection of the bid.

BID SUBMISSION REQUIREMENTS

Bid Bond

Each bid must be accompanied by a bid deposit, as earnest money, in the form of a bid bond, a certified check or cashier's check, drawn on a responsible bank, made payable to the *Village of Orland Park* for ten percent (10%) of the total amount of the bid price. After Contract award, the Village will return deposits to unsuccessful Bidders.

Only one (1) original bid bond document is required and is to be submitted with the paper copy to the Clerk's Office.

Responsible Bidder Ordinance Requirements

In the manner and to the extent required by 1-16-7 (Construction Bidding and Contracts) applicable to Village Code, on Village public works projects with a value of \$25,000 or more, the bidder/proposer must comply with the specific criteria set forth therein and submit acceptable evidence of such compliance, in addition to any other requirements as determined from time to time by the Village for the specific type of work to be performed.

Bidder/Proposer must meet all of the requirements per amended Village Code Section 1-16-7, including participation in apprenticeship and training programs applicable to the work to be performed on the project, with the United States Department of Labor's Bureau of Apprenticeship and Training or the Illinois Department of Labor, including the graduation of at least five (5) apprentices in each of the applicable construction crafts in the preceding five (5) years must provide certifications and supporting documents as proof.

Bidders shall notify the Village of any inappropriate service, brand name, component, or equipment called for by the Village in this ITB and shall note in its bid the adjustments made to accommodate such deficiencies.

After bids have been opened, no Bidder shall assert that there was a misunderstanding concerning the nature of the Project or the quantities and specifications of the material/equipment/items to be delivered, and no such claim shall relieve a Bidder from its obligation to perform. All bids must be made only on the forms provided by the Village and must be made in accordance with this ITB, which is on file and may be obtained for examination in the Clerk's Office at the above address and are made part of this notice as though fully set forth herein.

Required Forms

Bidders shall provide all the information requested in *Section III* of this ITB.

2. *Certificate of Compliance* – The Certificate of Compliance must be completed, signed, and submitted with the bid. The Certificate of Compliance is attached under separate cover.
3. *References* – The References form must be completed and submitted with the bid. Bidders shall provide three (3) references for which they have performed similar work. By providing this information, Bidders grant Village permission to contact said references and ask questions regarding prior work performance. Village may use the information gained from Bidder's references to further evaluate Bidder responsibility. The References form is attached under separate cover.
4. *Insurance Requirements* – The Insurance Requirements must be completed, signed and submitted with the bid. 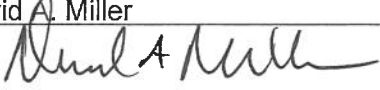

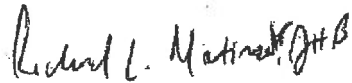

P. When Loss Is Payable

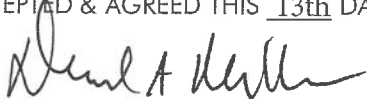
