THE FOLLOWING PERTAINS TO OUR PROPOSAL:

- 1. Disconnect and remove existing track lighting system.
- 2. Furnish and install strut system for new track support.
- 3. Furnish and install (2) new two circuit track system.
- 4. Furnish and install (16) dimmable LED heads four over each dispatcher.
- 5. Disconnect and remove (4) low voltage switches.
- 6. Furnish and install (4) low voltage dimmer switches.
- 7. Furnish and install (4) dimmer modules.
- 8. Furnish and install new cat 6 cables to (4) desks.
- 9. Furnish and install conduit, junction boxes and wire as needed.
- 10. Program and test all new devices.
- 11. All work performed during normal working hours.
- 12. Work due to concealed conditions not included.
- 13. Permit fees not included.

<u>Note:</u> The existing track system is no longer available from the manufacturer. We can't source the parts needed to convert this to a Led or repair the lights. A full new track system is required.
