- 4.0 Management activities (weed control) are for a two year time frame and include removal of non-native invasive species via chemical / mechanical methods. The purpose of this proposed project is to aesthetically improve the pond.
- 5.0 In the event that a prescribed burn is postponed due to weather any work done in preparation for the burn will be billed, and future prescribed burn will in turn be billed at full lump sum cost.
