The Village of Orland Park, Illinois ("VILLAGE") and Christopher B. Burke Engineering, Ltd. ("CBBEL")

WHEREAS, on January 28, 2019, a certain Agreement dated November 13, 2018 regarding Professional Engineering Services – Village Engineer Monthly Retainer between the Village and CBBEL was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify SCOPE OF WORK AND PAYMENT.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

- 1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
- 2. Agreement shall be amended to include Addendum A dated May 16, 2019 and the proposal dated April 5, 2019.
- 3. Under GENERAL ENGINEERING, the words "for a monthly retainer of \$8,500" shall be stricken in its entirety and replaced with "for a monthly retainer of \$18,100."
- 4. The scope of work shall be amended to include: "Storm Water Project Management engineering services provided by Mr. Travis Parry beginning May 13, 2019 through December 31, 2019 (approximately 16 hours per week). Storm Water Project Management services shall include current project status review to analyze and determine steps necessary to complete the project. The work shall include, but not be limited to, assistance with coordination with various Village departments and design engineers, permit tracking, bid phase, assistance during construction phase, and tasks necessary to complete the project."
- 5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
- 6. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the 16th day of May, 2019, shall be attached to and form a part of the Agreement dated the 13th day of November, 2018 and shall take effect upon signature below by duly authorized agents of both parties.



These General Terms and Conditions are expressly incorporated into and are an integral part of this contract for professional services. It should be emphasized that any requested meetings or additional services are not included in the preceding fee estimate and will be billed at the previously accepted Schedule of Charges. It is assumed that no federal funding or MFT funding will be utilized.
