RESOLUTION APPROVING AN AMENDMENT TO VILLAGE POLICY GOVERNING RESTRICTIONS IMPOSED UPON ORGANIZATIONS SELLING OR DELIVERING ALCOHOLIC BEVERAGES DURING SPECIAL EVENTS CONDUCTED ON VILLAGE PARKS

WHEREAS, on January 21, 2008, the Village President and Board of Trustees adopted a certain resolution entitled "RESOLUTION ESTABLISHING VILLAGE POLICY GOVERNING RESTRICTIONS IMPOSED UPON ORGANIZATIONS SELLING OR DELIVERING ALCOHOLIC BEVERAGES DURING SPECIAL EVENTS CONDUCTED ON VILLAGE PARKS" (the "Resolution"); and

WHEREAS, Subsection 3 of SECTION 1 provides "Only sale of or delivery of beer and wine shall be permitted";

WHEREAS, Subsection 4 of SECTION 1 provides "No glass containers shall be allowed"; and

WHEREAS, it has been determined that the Village interests would be better served if the type and containers of alcoholic beverages which may be sold or delivered during special events conducted on Village parks was left to the discretion and sound judgment of the Village President as the Village Liquor Commissioner.

NOW, THEREFORE, BE IT RESOLVED by the Village President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, as follows:

#### SECTION 1

Subsections 3 and 4 of SECTION 1 of the Resolution is hereby amended to read as follows:

- "3. The type of alcoholic beverages permitted to be sold or delivered (beer, wine or spirits as defined in Title 7, Chapter 4, of the Village Code) shall be as determined prior to the special event by the Village Liquor Commissioner.
- 4. No glass containers shall be allowed unless approved prior to the special event by the Village Liquor Commissioner."

In all other respects, the Resolution adopted January 21, 2008, shall remain in full force and effect.

#### **SECTION 2**

This Resolution shall be effective immediately upon its adoption.
