QUEEN OF HEARTS TICKET DISPENSER PLACEMENT AGREEMENT

This Queen of Hearts Ticket Dispenser Placement Agreement ("Agreement"), has been entered into this 200 day of November, 2021, by and between the Village of Orland Park, an Illinois municipal corporation, hereinafter referred to as the "Village," and MST Pizza Corporation, an Illinois corporation, operating under the assumed name of, and doing business as, Mackey's Public House, hereinafter referred to as "Mackey's Public House," is as follows:

WHEREAS, Mackey's Public House desires to have the Orland Park Veterans' Commission run a "Queen of Hearts" type Raffle (the "Event" or "Events") on its premises located at 9400 West 143rd Street, Orland Park, Illinois 60462 (the "Site"); and

WHEREAS, one of the ways in which the Orland Park Veterans' Commission would like to sell tickets for the Event is through a Ticket Dispenser Machine (the "Ticket Dispenser") located at the Site; and

WHEREAS, the Village desires to locate the Ticket Dispenser at the Site, and Mackey's Public House is agreeable to said placement, without any payment or compensation made to it, on the terms and conditions set forth herein.

NOW, THEREFORE, it is agreed as follows:

1. Placement of Ticket Dispenser: The Village shall install the Ticket Dispenser in a mutually agreed upon, indoor area at the Site, which is in plain view and readily accessible to the general public.

2. Mackey's Public House shall:

- a. Allow the Village or its designated agent access to the Site for the purpose of installing, inspecting, maintaining, servicing, repairing, replacing, upgrading and removing the Ticket Dispenser and or its contents and observe its use.
- b. Maintain the area around the Ticket Dispenser so that it is clean, safe, accessible and visible to the general public. Mackey's Public House agrees that the Ticket Dispenser shall at all times remain available for use by its customers during Mackey's Public House's normal business hours for the term of this Agreement.
- c. Use its best efforts to protect the Ticket Dispenser from theft and damage.
- d. Notify the Village promptly of any operating failures, theft, damage or problems with the Ticket Dispenser. Mackey's Public House will not permit anyone, other than an authorized representative or designee of the Village, to perform any service or repair work on the Ticket Dispenser without Village's prior written approval.
- e. Not post or allow to be posted on the Ticket Dispenser any signs, plaques, advertising or other material except as may be authorized in writing by the Village.
- f. Not attempt to open or place any tickets in or take any money out of the Ticket Dispenser.

g. In the event Mackey's Public House transfers or moves its business from the Site, or if Mackey's Public House sells its business, Mackey's Public House shall notify the Village not less than thirty (30) days prior to any such event.

3. The Village shall:

- a. Ship and install the Ticket Dispenser and deliver the supplies to Site. The Ticket Dispenser shall be and remain the sole property of the Village.
- Arrange for necessary servicing and repair of the Ticket Dispenser. Maintain the Ticket Dispenser and repair if required in a timely manner.
- c. Provide Mackey's Public House with any required instructions and training with regard to the operation of the Ticket Dispenser.
- d. Remove the Ticket Dispenser upon the termination of this Agreement
- 4. Term: The term of this Agreement shall commence upon the date that the Ticket Dispenser has been installed and is operational and shall continue until the Orland Park Veteran's Commission stops conducting the Event at the Site. Notwithstanding the foregoing, both the Village and Mackey's Public House retain the right to cancel this Queen of Hearts Ticket Dispenser Placement Agreement without cause upon ten (10) days written notice. In addition, the Village may terminate this Agreement immediately in the event of damage, destruction, vandalism, or misuse.
