The Village of Orland Park, Illinois ("VILLAGE") and Eternally Green Lawn Care, Inc. ("CONTRACTOR")

WHEREAS, on March 8, 2019, a certain Agreement regarding Fertilization & Broadleaf Weed Control 2019-2021 between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on February 4, 2021, a certain Agreement regarding Fertilization & Broadleaf Weed Control 2019-2021 between the Village and the Contractor was amended (hereinafter referred to as the "Addendum A"); and

WHEREAS, the Village wishes to modify SCOPE OF WORK AND PAYMENT and TERM OF THE CONTRACT.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

- 1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
- 2. <u>SECTION 1: THE CONTRACT DOCUMENTS</u> of said Agreement shall be amended to include Addendum B dated October 11, 2021.
- 3. <u>SECTION 2: SCOPE OF THE WORK AND PAYMENT</u> of said Agreement shall be amended to include a TOTAL amount not to exceed Two Hundred Three Thousand Twenty-Two and 30/100 (\$203,022.30) Dollars for each fiscal year 2022 and 2023.
- 4. <u>SECTION 4: TERM OF THE CONTRACT</u> of said Agreement shall be amended to include the approval of a two (2) year extension of the contract for fiscal year 2022 and 2023 on October 4, 2021.
- 5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
- 6. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the 11<sup>th</sup> day of October 2021, shall be attached to and form a part of the Agreement dated the 8<sup>th</sup> day of March 2019, amended the 4<sup>th</sup> day of February 2021, and shall take effect upon signature below by duly authorized agents of both parties.
