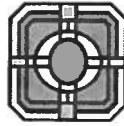

Landscape Management & Maintenance – Medians/Rights of Way

March 1, 2018

Between
The Village of Orland Park, Illinois ("VILLAGE") and Christy Webber Landscapes ("CONTRACTOR")

WHEREAS, on March 1, 2018, a certain Agreement regarding Landscape Management & Maintenance – Medians/Rights of Way between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify the SCOPE OF WORK.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 1: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include "Addendum A dated October 19, 2018" and "Proposal #JO180120 dated 9/26/18"
3. **SECTION 2: SCOPE OF THE WORK AND PAYMENT** of said Agreement shall be amended to include the following:
 - ROW/MEDIANS IMPROVEMENTS**
 - Replace dead plant material on medians and ROW as defined in proposal JO180120 for an amount not to exceed Thirty Thousand Eighty-Three and No/100 (\$30,083.00) Dollars
4. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
5. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the 19th day of October, 2018, shall be attached to and form a part of the Agreement dated the 1st day of March, 2018 and shall take effect upon signature below by duly authorized agents of both parties.
