

## ADDENDUM B TO THE TASTE OF ORLAND PARK TENTS, TABLES, AND OTHER RENTAL EQUIPMENT, DATED APRIL 1, 2024, AMENDED SEPTEMBER 23, 2024 BETWEEN

## THE VILLAGE OF ORLAND PARK AND INDESTRUCTO RENTAL COMPANY, INC.

WHEREAS, on April 1, 2024, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and Indestructo Rental Company, Inc. (hereinafter referred to as "Consultant") for the performance of certain professional services for the Village in connection with Taste of Orland Park Tents, Tables & Other Rental Equipment (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on September 23, 2024, a certain Agreement between the Village and the Consultant for the Taste of Orland Park Tents, Tables, and Other Rental Equipment was previously amended (hereinafter referred to as the "Addendum A"); and

WHEREAS, the Village wishes to modify SCOPE OF WORK, COMPENSATION, AND CONTRACT DOCUMENTS.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

- 1. In the event of any conflict or inconsistency between the provisions of this Addendum B and the Agreement, the provisions of this Addendum B shall control.
- 2. **SECTION 1: SCOPE OF THE WORK** of said Agreement shall be amended to include the "Scope of Work" as set forth in Consultant's Proposal, dated July 29, 2025, for the rental of additional equipment (tents, weights, lights, tables, chairs) for the 2025 Taste of Orland Park.
- 3. **SECTION 2A: COMPENSATION** in said Agreement shall be amended to strike a "not-to-exceed amount of \$19,628.00, plus a contingency of \$2,944.20 per year for three (3) years 2024 2026 for a total of \$22,572.20 ("Contract Price") per year, and the option to extend for two (2) additional years, 2027-2028 at an amount to exceed the Board approved budget amounts."

And replace with

a new "Total not-to-exceed contract amount of \$33,576.00 for 2025, a not-to-exceed amount of \$19,628.00, plus a contingency of \$2,944.20 for a total not to exceed amount of \$22,572.20 ("Contract Price") for 2026"; and the option to extend for two (2) additional years, 2027 – 2028 at amounts not to exceed the Board approved budgeted amounts." The contract was increased by \$11,003.80 for 2025.

- 4. **SECTION 3: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum B, dated August 4, 2025: and "Proposal for Work, dated July 29, 2025
- 5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.

6. This Addendum B may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum B, made and entered into effective the **4**<sup>th</sup> **day of August, 2025**, shall be attached to and form a part of the Agreement dated the 1<sup>st</sup> day of April, 2024, amended September 23, 2024, and shall take effect upon signature below by duly authorized agents of both parties.

IN WITNESS WHEREOF, the parties have caused this Addendum B to be executed by their duly authorized officer in quadruplicate counterparts, each of which shall be considered as an original.
