On April 4, 2022, the Village Board approved awarding USIC as a sole source provider to locate all Village-owned street light cables. USIC was awarded a one (1) year contract with an option to extend an additional two (2) years.

Whenever digging or excavation takes place on a property, residents or contractors contact J.U.L.I.E. to have underground utilities located. Currently, when those requests come into the Village, USIC personnel locate all Village-owned street light cables while
