



**ADDENDUM C TO SOUND WORKS PRODUCTION GROUP DBA VANTAGE PRODUCTION GROUP, DATED MARCH 18, 2024, AMENDED MAY 19, 2025, AMENDED AUGUST 4, 2025
BETWEEN
THE VILLAGE OF ORLAND PARK AND SOUND WORKS PRODUCTION GROUP DBA VANTAGE PRODUCTION GROUP**

WHEREAS, on March 18, 2024, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and Sound Works Production Group DBA Vantage Production Group (hereinafter referred to as "Consultant") for the performance of certain professional services for the Village in connection with Centennial Park West Lighting, Sound, Truss, Rigging & Other Rental Equipment (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on May 19, 2025, a certain Agreement between the Village and the Consultant for the Centennial Park West Lighting, Sound, Truss, Rigging & Other Rental Equipment was previously amended (hereinafter referred to as the "Addendum A"); and

WHEREAS, on August 4, 2025, a certain Agreement between the Village and the Consultant for the Centennial Park West Lighting, Sound, Truss, Rigging & Other Rental Equipment was previously amended (hereinafter referred to as the "Addendum B"); and

WHEREAS, the Village wishes to modify SCOPE OF WORK, COMPENSATION, CONTRACT DOCUMENTS, TERM OF THE CONTRACT.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum C and the Agreement, the provisions of this Addendum C shall control.
2. **SECTION 1: SCOPE OF THE WORK** of said Agreement shall be amended to include the "Scope of Work" as set forth in Consultant's Proposal, dated May 20, 2026 the Centennial Park West Concert Series on June 20, July 11 and August 28; six weeks of Concerts in the Park, the Fourth of July and a Patriot Day concert on September 11, 2026 at Centennial Park West
3. **SECTION 2A: COMPENSATION** in said Agreement shall be amended to explicitly state the budgeted approved amount of \$91,800.00 for FY2026; increase the contract by \$54,368 for FY2026 for a not-to-exceed amount of \$146,168 ('Contract Price') for FY2026.
4. **SECTION 3: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum C, dated June 1, 2026: and "Proposal for Work", dated May 20, 2026.
5. **SECTION 4A: TERM OF THE CONTRACT** of said Agreement shall be amended to strike the contract termination date of August 30, 2026 and replace with a revised contract termination date of February 28, 2027.
6. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.

7. This Addendum C may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum C, made and entered into effective the 1st day of June 2026, shall be attached to and form a part of the Agreement dated the March 18, 2024, amended May 19, 2025 and amended August 4, 2025 and shall take effect upon signature below by duly authorized agents of both parties.

IN WITNESS WHEREOF, the parties have caused this Addendum C to be executed by their duly authorized officer in quadruplicate counterparts, each of which shall be considered as an original.
