Dear Mr. Wilmes:

On behalf of V3 Companies of Illinois, Ltd., we are pleased to submit this proposal for civil engineering services on the above-referenced project. If you find this proposal to be acceptable, the executed copies of this letter, together with the General Terms and Conditions attached hereto, which sets forth the contractual elements of this agreement, will constitute the entire agreement between The Village of Orland Park, Illinois (CLIENT) and V3 Companies of Illinois, Ltd. for services on this project.

Project Understanding

Based upon your email dated July 18, 2006, and consequent discussions, it is our understanding that the project will consist of the extension of Ravinia Avenue from the east property line of the Costco Wholesale Development to the west property line of the Main Street Village - West Development consisting of approximately 1,000 feet of roadway. It is anticipated that the services required for this extension will include surveying, wetland delineation, stormwater management, paving, grading, utility, and lighting design.

In addition to the professional services fees set forth above, V3 shall be compensated for 110% of reimbursable expenses such as printing, postage, messenger service, travel and other similar project-related items. The total amount of reimbursable expense shall not exceed \$2,500 without prior written approval by the CLIENT. Please note that the budget for reimbursable expenses is included in the maximum payable amount of \$138,600 above.

Miscellaneous Contractual Items

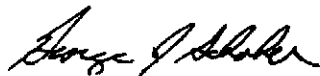
V3 will initiate its services promptly upon receipt of CLIENT's acceptance of this proposal.

If there are protracted delays for reasons beyond V3's control, an equitable adjustment of the above-noted compensation shall be negotiated taking into consideration the impact of such delay on the pay scales applicable to the period when V3's services are, in fact, being rendered.

If CLIENT or other interested parties request a computer disk of design data, V3 shall be indemnified from any claims arising out of the accuracy, misuse or reuse by others of the data delivered in disk form.
