The Village of Orland Park, Illinois ("VILLAGE") and MEADE, INC. ("CONTRACTOR")

WHEREAS, on February 1, 2020, a certain Agreement regarding Traffic Signal Maintenance between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on December 23, 2020, a certain Agreement regarding Traffic Signal Maintenance between the Village and the Contractor was amended (hereinafter referred to as the "Addendum No. 1"); and

WHEREAS, on December 20, 2021, a certain Agreement regarding Traffic Signal Maintenance between the Village and the Contractor was amended (hereinafter referred to as the "Addendum No. 2"); and

WHEREAS, the Village wishes to modify the TERM OF CONTRACT.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 1: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum 2 dated December 20, 2021.
3. **SECTION 2: TERM OF THE CONTRACT** of said Agreement shall be amended to read as follows:

The term for this Agreement shall be for a period of one (1) year from January 1, 2022 to December 31, 2022, with an option to renew for a one (1) year term.

4. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
5. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.
