

WHEREAS, on April 22, 2013, a certain Agreement regarding Forever Green Lawn Care between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to extend the term of the agreement through December 31, 2018 at 2015 rates.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 1: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum A dated November 6, 2015.
3. **SECTION 2: SCOPE OF THE WORK AND PAYMENT** of said Agreement shall be amended to include the following:

Classification I (Parks)	\$ 21,832.47
Classification II (Parks)	\$ 37,153.12
Classification IV (Parks)	\$ 3,850.00
Classification II (Public Works)	\$ 220.80
Classification IV (Public Works)	\$ 6,562.36
TOTAL per Year	\$ 69,618.75

4. **SECTION 4: TERM OF THE CONTRACT** of said Agreement shall be amended to strike the following:

"The WORK shall commence upon a receipt of a Notice to Proceed. The term of this contract shall be for one seasonal year (2013) but shall be automatically renewed on calendar year end (December 31st) for each of two (2) successive years unless the Village notifies the Contractor in writing at least thirty (30) days before said anniversary date that it does not wish to renew the contract."

"The WORK shall commence upon receipt of a Notice to Proceed and continue annually until final completion on December 31, 2018. This Contract shall terminate upon completion of the WORK or December 31, 2018, whichever occurs first, but may be terminated by either of the PARTIES for default upon failure to cure after ten (10) days prior written notice of said default from the aggrieved PARTY. The VILLAGE, for its convenience, may terminate this Contract with thirty (30) days prior written notice."

5. All of the other terms, covenants, representations and conditions of said Agreement, not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
6. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the **6th day of November, 2015**, shall be attached to and form a part of the Agreement dated the 22nd day of April, 2013 and shall take effect upon signature below by duly authorized agents of both parties.
