1. Furnish and install new fire alarm devices below to the existing system to bring building up to current codes.

 - Qty: 2 Backup Batteries
 - Qty: 3 Horn Strobes, Wall Mount Weatherproof
 - Qty: 4 Smoke Detectors
 - Qty: 2 Pull Station
 - Qty: 3 Outdoor Horn Strobes
 - Qty: 1 CO Detector
 - Qty: 1 Annunciator panel
 - Qty: 1 Monitor Module
 - Qty: 1 Knox Box
2. Furnish and install approximately 600' of new 3/4" fire alarm conduit for new devices.
3. Furnish and install 28 fire alarm device boxes.
4. Furnish and install approximately 3500' of 2 conductor wire for new devices.
5. Provide engineering, programming and complete testing of all components installed and final check out of a proper operating system upon completion of project.
6. Drawings and submittals for approval to the local AHJ only. If the local AHJ uses an outside source to review drawings their fees will be an additional charge. This proposal does not include a PE stamp or any fees associated with obtaining a PE stamp. If a PE stamp is required it will be an additional charge. Zone maps are not included.
7. All work performed during normal working hours.
8. Work due to concealed conditions not included.
