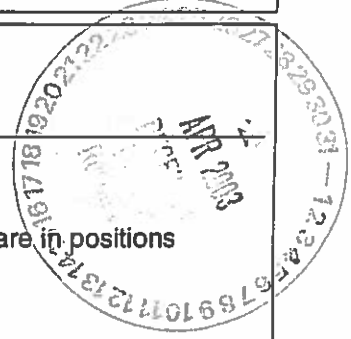
is a participant in the Illinois Municipal Retirement Fund; and
