Neighborhood Road Program 2017 Contract

Dated

Between
The Village of Orland Park, Illinois ("VILLAGE") and Austin Tyler Constructon, Inc. ("CONTRACTOR")



WHEREAS, on May 5, 2017, a certain Agreement regarding Neighborhood Road Program 2017) between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to increase the TOTAL amount of the contract by \$400,000.00.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 1: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include "Addendum A dated August 17, 2017"
3. **SECTION 2: SCOPE OF THE WORK AND PAYMENT** of said Agreement shall be amended to strike the following in its entirety: "TOTAL: an amount not to exceed Three Million Eleven Thousand Six Hundred Eleven and 22/100 (\$3,011,611.22) Dollars" and replace with the following: TOTAL: an amount not to exceed Three Million Four Hundred Eleven Thousand Six Hundred Eleven and 22/100 (\$3,411,611.22) Dollars
4. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
5. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the 17th day of August, 2017, shall be attached to and form a part of the Agreement dated the 5th day of May, 2017 and shall take effect upon signature below by duly authorized agents of both parties.
