Cost of Crane

Crane rental:

\$180 per hour straight time
\$260 per hour overtime

4 hour minimum rental per day
8 hour minimum on SAT, SUN

Note: There is a 4 hour minimum rental of this machine per workday. The local 150 operating engineer workday consists of leaving the yard at 7am and returning by 3:30pm, Monday through Friday portal to portal. Work performed before or after these hours will be considered overtime. Stevenson is not responsible for site conditions. Machines are subject to availability.

Note: This crane will have to attach and detach the swing-away fixed jib that is stowed on the main boom. It will take approximately one hour to attach jib and one hour to detach jib. Please figure your needs accordingly.
