**ADDENDUM A TO VACTOR VACUUM EXCAVATOR, DATED FEBRUARY 28, 2022,
BETWEEN
THE VILLAGE OF ORLAND PARK AND STANDARD EQUIPMENT CO.**

WHEREAS, on February 28, 2022, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and Standard Equipment Co. (hereinafter referred to as "Contractor") for the performance of certain professional services for the Village in connection with Vactor Vacuum Excavator (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify CONTRACT DOCUMENTS and DATE OF COMPLETION.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 4: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum A, dated November 1, 2022.
3. **SECTION 5A: TERM OF THE CONTRACT** of said Agreement shall be amended to strike the completion date of December 31, 2022, and include a new completion date of March 31, 2023.
4. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
5. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.


