## Staff Report to the Plan Commission

Land Development Code Amendment – Allow Outdoor Fireplaces in all Zoning Districts

Case Number: 2025-0746

Prepared: 9/12/2025

### AMENDMENT SUMMARY

- Allow Outdoor Fireplaces in all zoning districts, which are currently prohibited in the BIZ General Business and VCD Village Center Zoning Districts.
- Update the Detached Accessory Structure tabled updated to reflect this change.

### AMENDMENT EXPLANATION

Outdoor fireplaces are not permitted in the BIZ or VCD Districts in the Land Development Code despite being located at many restaurant patios and residential common areas or courtyards.

This amendment would permit outdoor fireplaces as accessory structures in all zoning districts, subject to being located in the rear yard, except as otherwise permitted for restaurant patios. In addition to complying with location, setback, and safety standards, all outdoor fireplaces are still subject to the International Building Code and International Fire Code regulations.

Non-single-family properties must obtain Appearance Review approval before applying for permits and installing any outdoor fireplace.

### PROPOSED AMENDMENT TEXT

#### SECTION 6-302.C.23 – ACCESSORY STRUCTURES AND USES

...

23. **Outdoor Fireplaces:** May be permitted in rear setbacks at least ~~five (5) feet~~ **5'** from the lot line in all districts, ~~except the BIZ General Business District, Village Center District and~~ except as otherwise permitted for outdoor eating areas in commercial districts.
