ADDENDUM B TO Risk Management & Loss Control Services, DATED April 8, 2020

Amended July 18, 2022

BETWEEN

THE VILLAGE OF ORLAND PARK AND LT Contractual Risk Solutions, Inc./Titan Safety Management, Inc.

WHEREAS, on April 8, 2020, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and LT Contractual Risk Solutions, Inc./Titan Safety Management, Inc. (hereinafter referred to as "Consultant") for the performance of certain professional services for the Village in connection with Risk Management & Loss Control Services (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on July 18, 2022, a certain Agreement between the Village and the Consultant for the Services is amended (hereinafter referred to as the "Addendum A"); and

WHEREAS, on October 6, 2022, a certain Agreement between the Village and the Consultant for the Services is amended (hereinafter referred to as the "Addendum B"); and

WHEREAS, the Village wishes to modify SCOPE OF WORK AND PAYMENT.

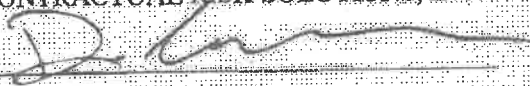
NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 2: SCOPE OF THE WORK** of said Agreement shall be amended to include the "Scope of Work" as set forth in LT Contractual Risk Solutions, Inc. Proposal, Exhibit B.
3. **SECTION 2: PAYMENT** in said Agreement shall be amended to strike, "Eighty-Six Thousand and No/100 (\$86,000)" and add the words Eight-One Thousand and No/100 (\$81,000).
4. **SECTION 2: PAYMENT** in said Agreement shall be amended to strike the words "an additional amount not to exceed \$10,500 for FY2022 and \$8,000 for FY2023" and add "an additional amount not to exceed \$8,000 for FY2022 and \$5,500 for FY2023 for LT Contractual Risk Solutions, Inc.";
5. **SECTION 3: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum B, dated October 6, 2022: and "Proposal for Work, Exhibit B"
6. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
7. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the **6 day of October, 2022**, amended the **18 day of July, 2022**, shall be attached to and form a part of the Agreement dated the 8 day of April, 2020, and shall take effect upon signature below by duly authorized agents of both parties.
