The Village of Orland Park, Illinois ("VILLAGE") and Total Building Services, Inc. ("CONTRACTOR")

- 1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
- 2. This addendum amends the terms of the services provided at the Sportsplex, 11351 W. 159th Street, Orland Park, IL 60462 during the period April 1, 2010 through September 30, 2010. At the sole discretion of the Village, this addendum may be extended to year 2011 at the same rate of compensation. The Village shall provide written notification to Contractor of its intention to renew this addendum at least thirty (30) days prior to the beginning of summer hours as defined under item 3 below.
- 3. Under ARTICLE 1: SCOPE, of said Agreement (amended February 10, 2009) under "**" on page 2, the sentence "During summer hours at the Sportsplex (approximately mid-June through Mid-September), the 1st and 2nd shifts will be combined into one shift from 10:30am 7:00pm Monday thru Friday and 8:00am 5:00pm Saturday and Sunday, and the 3rd shift will remain the same from 11:30pm 7:30am seven (7) days per week" shall be stricken and replaced with "During summer hours at the Sportsplex (April 1 September 30), the 1st and 2nd shifts will be combined into one shift from 10:30am 7:00pm Monday thru Friday and 8:00am 5:00pm Saturday and Sunday, and the 3rd shift will remain the same from 11:30pm 7:30am seven (7) days per week."
- 4. Under ARTICLE 6: COMPENSATION, the sentence amended February 10, 2009 to read "For the period mid-June through mid-September (i.e. June 15 Sept 13, 2009; June 14 Sept 12, 2010; June 13 Sept 11, 2011), the Village agrees to pay Contractor a sum of Nine Thousand Nine Hundred Sixty-Five and No/100 (\$9,965.00) Dollars per month for custodial services at the Sportsplex, reducing total monthly compensation to Twenty Seven Thousand Three Hundred Seventy-Five and No/100 (\$27,375.00) Dollars per month" shall be stricken and replaced with "For the period April 1 through September 30, the Village agrees to pay Contractor a sum of Nine Thousand Nine Hundred Sixty-Five and No/100 (\$9,965.00) Dollars per month for custodial services at the Sportsplex, reducing total monthly compensation to Twenty Seven Thousand Three Hundred Seventy-Five and No/100 (\$27,375.00) Dollars per month."
- 5. All of the other terms, covenants, representations and conditions of said Agreement, not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
