ADDENDUM A to
Purchase of Liquid Chlorine 2015-2017

Between
The Village of Orland Park, Illinois ("VILLAGE") and Mineral Masters ("VENDOR")

WHEREAS, on April 20, 2015, a certain Agreement regarding Purchase of Liquid Chlorine 2015-2017 between the VILLAGE and the VENDOR was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the VILLAGE wishes to extend the term of the agreement.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 1: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include "Addendum A dated March 1, 2018"
3. **SECTION 2: GOODS TO BE PURCHASED, COST AND DELIVERY:** of said Agreement shall be amended to include the following:

Sodium Hypochlorite (Liquid Chlorine) 18%	\$1.18	TBD (no more than 5% increase)

4. **SECTION 4: TERM OF THE CONTRACT** of said Agreement shall be amended to strike the following in its entirety:
"The VENDOR shall deliver the first shipment of GOODS on May 15, 2015, followed with weekly Friday deliveries thereafter throughout the pool season (May 23 - September 4, 2015). Similar dates shall be applied to the 2016 and 2017 pool seasons. This CONTRACT shall terminate after final delivery 2017 or September 10, 2017, whichever occurs first."

And replaced with:

"The VENDOR shall deliver the first shipment of GOODS on May 15th of each year, followed with weekly Friday deliveries thereafter throughout the pool season (Memorial Day Weekend through Labor Day). This CONTRACT shall terminate after final delivery in 2020. The VILLAGE, for its convenience, may terminate this Contract with thirty (30) days prior written notice."

5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
6. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.
