Dear Mike,

Thank you for contacting Davey Resource Group, Inc., "DRG" to provide you with this proposal to complete the scope of services listed below at Arbor Lake Park in Orland Park, IL. This proposal is inclusive of all labor, material, and equipment required to perform the scope of work listed below.

### **Scope of Work**

#### **Initial Selective Clearing - All Units:**

Our approach will be to cut drop and chip as we clear so that we keep the trails open and clear from debris during after hours. Equipment such as a tracked skid steer, tracked mini excavator, tow behind chipper and dump truck will be on site working off of the trail system. The trail will need to be closed during felling operations and will be monitored to ensure public safety. Woodchips generated will either be stockpiled for future layout or will be placed on the path as we progress. Any trees that pose a hazard to the utility lines or the road will be cut using a climber and/or bucket truck and will be dropped safely within the unit itself.

#### **Woodchip Distribution - Paths and Landing:**

Either post clearing and chipping operations or during, wood chips will be placed onto the path using a tracked skid steer and will be raked in place by hand.

#### **Seeding - All Units:**

Seeding of Units will be conducted via hand broadcast.

#### **Seeding - Hydromulch:**

Hydromulch will be installed using a Finn T60 hydromulcher and will be conducted immediately after the seed is installed.

#### **Stewardship during the 2026 Season:**

Visits for stewardship will be made throughout the growing season to control weeds within the Pond/Wetlands. Control methods will include hand cutting, pulling, selective mowing, and herbicide application as appropriate. Stewardship efforts will focus on particular weed problems as they arise throughout the season and will be directed by the recommendations of the field supervisor. Pricing reflects multiple sites being managed on the same day.

All work is done under the general supervision of a field supervisor. Our field staff is uniformed and supervised by working foreman. All vehicles and equipment are marked with the company logo. This allows you the assurance of easy identification of our equipment and personnel.

This proposal can be implemented by either issuing a purchase order, or by signing the Authorization to Proceed below and returning it to our office. Please feel free to only choose the line items for the work you would like DRG to perform at this time.
