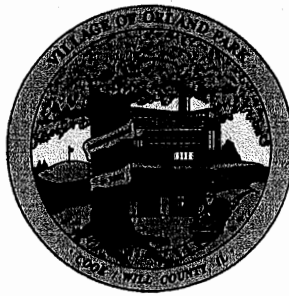

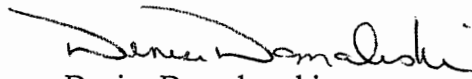

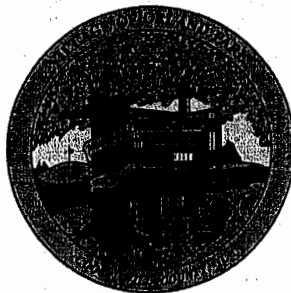

NOTICE OF AWARD – Turf Mowing 2010-2013

Dear Mr. Limanowski:

This notification is to inform you that on October 18, 2010 the Village of Orland Park Board of Trustees approved awarding Mid America Tree & Landscape, Inc. the contract in accordance with the proposal you submitted dated September 14, 2010 for Turf Mowing for three years (2011, 2012, 2013) at the 2010 price per acre of \$19.75, minimum cost \$9.00. Nuisance mowing will be charged a rate of \$45.00 per acre.

Beginning in 2011, the Village of Orland Park requests that Public Works billing be split between ponds and right-of way. You will receive updated property lists prior to 2011 mowing season from Public Works, and Parks and Recreation.

I am enclosing the addendum for Turf Mowing 2011-2013. Please sign two (2) copies and return them both directly to me. I will obtain signatures to fully execute the Contract and one original executed Contract will be returned to you. Please deliver this information directly to me, Denise Domalewski, Contract Administrator, at Village Hall located at 14700 S. Ravinia Ave., Orland Park, IL 60462. You will be issued a *Notice to Proceed* letter and a purchase order when you are in full compliance with this process. Failure to comply with these conditions within the time specified will entitle the Village to consider your proposal abandoned and to annul this Notice of Award. ADDENDUM to
Turf Mowing Contract

Dated
December 20, 2007

Between
The Village of Orland Park, Illinois ("VILLAGE") and Mid-America Tree & Landscape, Inc.
("CONTRACTOR")

RE: Extension of contract for three (3) additional years (2011, 2012 & 2013) at the 2010 prices.

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. In **SECTION 13: Payment for Services**, the sentence "Contractor shall bill each department separately" shall be stricken in its entirety and replaced with the sentence "Contractor shall bill each department separately (Parks, Public Works – Ponds, and Public Works – ROW)."
3. In **SECTION 19: Term of Agreement** of said Contract, the sentence "This Agreement shall become effective upon execution of said Agreement by both parties and shall remain in effect up to and including midnight, December 31, 2010" shall be stricken and replaced with the following sentence "This Agreement shall become effective January 1, 2011 and shall remain in effect up to and including midnight, December 31, 2013."
4. All of the other terms, covenants, representations and conditions of said Agreement, not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
5. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the **1st day of January, 2011**, shall be attached to and form a part of the Agreement dated the 20th day of December, 2007 and shall take effect upon signature below by duly authorized agents of both parties.

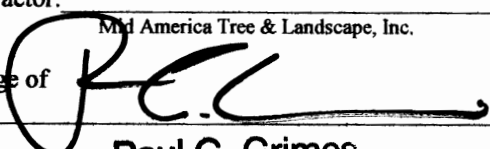
