WHEREAS, on July 11, 2014, a certain Agreement regarding Storm Water Basin Management 2014-16 between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify the scope of the agreement; and

WHEREAS, the Village wishes to extend the term of the agreement.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 1: THE CONTRACT DOCUMENTS:** of said Agreement shall be amended to include the following in the list of CONTRACT DOCUMENTS:
"Any and all addenda issued under these contract terms"
3. **SECTION 2: SCOPE OF THE WORK AND PAYMENT** of said Agreement shall be amended to include the following:

4. **SECTION 2: SCOPE OF THE WORK AND PAYMENT** of said Agreement shall be amended to include the following:

The TOTAL amount shall be increased by Sixteen Thousand Six Hundred Eight and 11/100 (\$16,608.11) Dollars for the 3-year service 2015-17 on Julie Ann Lane Pond (addendum A).

5. **SECTION 4: TERM OF THE CONTRACT** of said Agreement shall be amended to strike the following in its entirety:

"The CONTRACTOR shall commence the WORK of this Contract upon receipt of a Notice to Proceed and continue expeditiously from that date until completion or December 31, 2016, whichever comes first, (hereinafter referred to as the "CONTRACT TIME")."

**Julie Ann Lane Pond
Proposal Form**

Julie Ann Lane Pond appears to have had native seed installed within the last 2-3 years. However, the dominant plant species on some portions of the shoreline buffers are invasive species and weeds. In these areas of heavy weed presence, all vegetation must be eradicated, with the installation of additional native seed and plugs to improve the existing buffer. A rigorous weed control program must then be put in place to prevent the buffer from reverting back to its current condition. Below are the recommendations for restoration and 3 years of maintenance.
