3 of us went on the "field trip" to visit this site earlier this afternoon. The installation of solar panels is clearly complete.

Panels are on the east and south sides of this house. Didn't like the white connecting cables/conduit (between panels) and the white "dots" between the individual cells on each panel. Dr. Shah had indicated to us that he/they will use black connecting cables/conduit. Don't know about the "dots".

The home across the street from 17606 Karli Lane is for sale. We called the realtor and left a message, inquiring about how prospective buyers have viewed and/or commented on the solar panels across the street and directly in view. We hope for a prompt response. The obvious question is the impact that they may have on both "sellability" and price.
