
We have prepared this Letter of Understanding (LOU), in duplicate, between Cook County and the Village of Orland Park to establish responsibilities for new sidewalk that will be installed as part of the County's improvement along 108<sup>th</sup> Avenue from 179<sup>th</sup> Street to 163<sup>rd</sup> Place in the Village of Orland Park and unincorporated Orland Township. Said sidewalk (estimated total 425 feet) will be installed at Victoria Place along the west parkway and south of Landings Drive along the east parkway; and, both segments are located in unincorporated Orland Township.

The Village of Orland Park shall pay for fifty (50%) percent of the construction costs associated with the sidewalk installation (estimated total cost \$25,000.00) and shall own, operate and maintain said sidewalk installed as part of the improvement along 108<sup>th</sup> Avenue.

It is mutually understood that this Letter of Understanding is not a legally binding agreement. Therefore, following Village concurrence to this LOU, a formal Agreement will be prepared by the Highway Department to formalize our specific project costs, maintenance responsibilities and terms for reimbursement from the Village of Orland Park to Cook County.

Retain one copy and return the other original signed copy to this Department at your earliest convenience.
