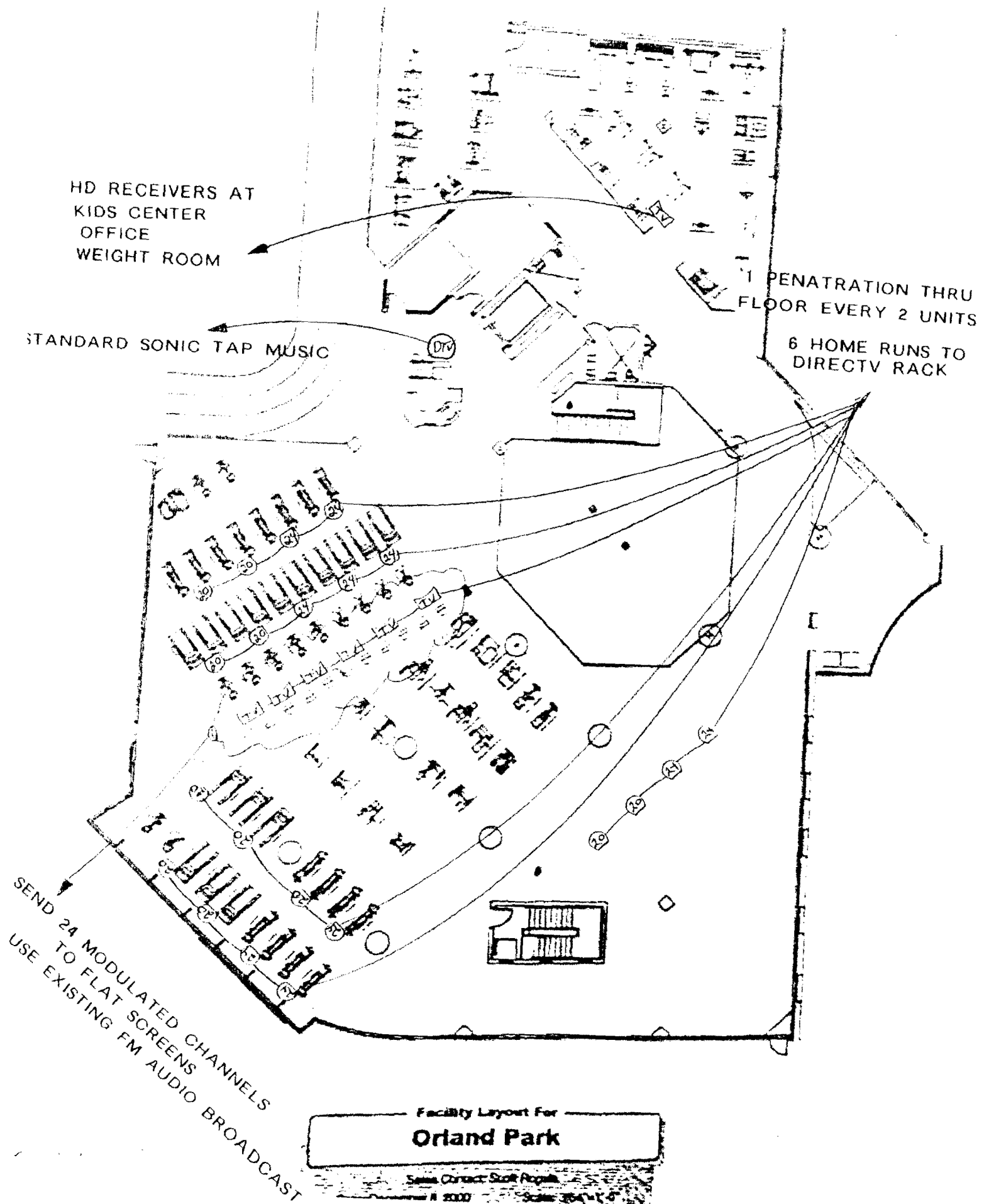

About Your System...

Per your request, Plus One AV will furnish and install the Distributed Antenna system upgrades to the 52 locations as discussed in the SportsPlex walk thru.

We will use the existing Comcast signal that is connected to the existing televisions and divide and extend the RF signal to the three (3) areas, for the new 52 exercise machines.

We propose to install one (1), small surface mounted equipment racks in each of the three (3) areas where the new exercise equipment is to be located. Inside these equipment racks shall house the video signal distribution amplifiers needed for that exercise area. From the equipment rack we shall install surface mounted metal raceway, across the floor, for the RG6 coaxial cable that shall connect each machine to the distribution amplifiers in each area.

All of the electronic equipment shall be located in the small wall mounted equipment racks, a/c power shall be required at each of these equipment racks.

Once the listed equipment is installed and connected, the antenna system shall be adjusted for the best optimum picture.

- A finance charge of 1.5% per month will be assessed if the invoice remains open for Thirty-One (31) days.

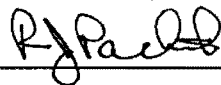
Payment; Default

Terms of payment shall be Net 30 days after date of invoice. Until the Purchaser pays the full purchase price of the merchandise sold hereunder, Plus One AV ("Company") shall have, and is hereby granted by the Purchaser, a purchase money security interest in the equipment sold hereunder in accordance with the Uniform Commercial Code.
