AN ORDINANCE AMENDING TITLE 5 (BUILDING), CHAPTER 2 (BUILDING PERMITS AND FEES), OF THE ORLAND PARK VILLAGE CODE REGARDING APPLICATION AND BUILDING PERMIT FEES FOR THE VILLAGE OF ORLAND PARK

WHEREAS, the Village of Orland Park, (hereafter the "Village") is a home rule municipality and pursuant to the Illinois Constitution, Article VII, Section 6, has certain powers which it is exercising; and

WHEREAS, the Village may regulate the issuance of building permits within the Village of Orland Park pursuant to its home rule authority and pursuant to the Illinois Municipal Code; and

WHEREAS, in exercise of its home-rule authority, the Village, through its President and Board of Trustees, has found and determined that it is in the best interest of the Village and its residents that a permit application fee be established for all permits, and a per square foot fee for single family residential new construction and building additions replace the existing regulations.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ORLAND PARK, COOK AND WILL COUNTIES, ILLINOIS AS FOLLOWS:

SECTION 1

That the findings contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this ordinance.

SECTION 2

That Sections 5-2-4, 5-2-5, 5-2-6, 5-2-7, 5-2-9, and 5-2-10 of the Orland Park Municipal Code are hereby modified by adding and removing the following text as follows (deleted text marked with ~~strike through~~, new text marked with underline):

5-2-4 : PERMIT AND INSPECTION FEES REQUIRED:

Every applicant for a permit from the Village of Orland Park Development Services Department shall pay \$95.00 at time of application, and, prior to receiving a permit, pay the balance ~~such~~ of the following fees as are applicable to said permit. (Ord. 4491, 6-15-09)

Re-review fees after the second review are based on \$60.00 for residential 1 and 2 family reviews per hour or fractions thereof, minimum \$95.00. Commercial re-review fees after the second review are based on \$90.00 per hour or fractions thereof, minimum \$95.00. (Ord. 3819, 10-6-03; Amd. Ord. 3911, 7-19-04; Amd. Ord. 4491, 6-15-09; Amd. For new construction of and additions to single family residential, both attached and detached, a per square foot building permit fee shall apply per the following schedule for the building area:

- a. 2,000 SF or less: \$1.70/SF
- b. For each additional SF greater than 2,000 SF: \$0.50/SF

5-2-7-1-2 : FIXED FEE PERMITS (small improvements):

For installation of an approved rain detection ~~device~~ device on an existing lawn sprinkler system without such a device, a permit must be obtained, but there shall be no permit fee. n. Special Inspection and Services Performed:

Any persons requesting special or non-emergency services performed by the Village during or after normal business hours, including inspection, evaluation and/or a review shall pay fees as shown below:

1. A \$300.00 2-hour minimum fee plus ~~\$90~~95.00 for each additional hour or portion thereof for each type of inspection service. The fee may include the additional time needed for consulting and recording of operations performed. Fees are based on all costs involved to the Village including an overtime wage rate for staff employee(s).

2. Independent services that are performed by other than Village personnel, shall be paid for by the person(s) requesting such service(s). In addition to the independent service fee, the Village shall collect an additional 10% of that special service fee for the village's administrative review, management and record keeping operations.

Except for Plan Review and Permit Application Fees, when fees have been paid pursuant to the above sections, and a permit is canceled, the permit applicant will be entitled to a refund of such fees that are in excess of any charges or expenses (including manpower costs) incurred by the Village prior to cancellation.

SECTION 3

All Ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

SECTION 4

If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid, such decision or decisions shall not affect the validity of the remaining portions of this Ordinance.
