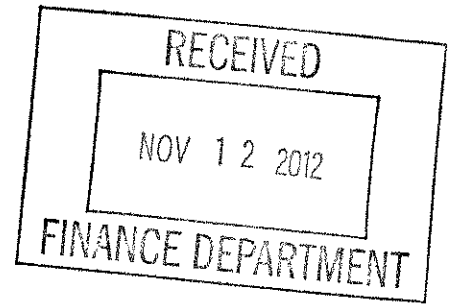

RE:           Extension of contract term for 2012

1.     In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2.     In Item 4: Description of Work, of said Agreement as amended October 18, 2011 the words "...for the 2011 holiday season" shall be stricken and replaced with the words "...for the 2012 holiday season."
3.     In Item 9: Contract Documents, of said Agreement as amended October 18, 2011 , the words "Contractor's Invoice dated October 1, 2011" shall be stricken and replaced with "Contractor's Invoice dated October 11, 2012".
4.     Item 10: Period of Performance, of said Agreement as amended on October 18, 2011, shall be stricken in its entirety and replaced with the following:

10. Period of Performance. Installation of decorations will begin on November 12, 2012 and will be completed and in good working order by November 24, 2012 in anticipation of the Village Lighting Ceremony on November 25, 2012. All displays along Ravinia Ave. and Centennial Park will be taken down beginning the week of January 2, 2013 with removal complete no later than January 11, 2013.
5.     Item 22: Term of Agreement, of said Agreement as amended October 18, 2011, the words in the last sentence "...up to March 15, 2012," shall be stricken and replaced with "...up to March 15, 2013,".
6.     All of the other terms, covenants, representations and conditions of said Agreement, not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
7.     This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.
