**WHEREAS**, Ballet 5:8 is now the largest nonprofit performing arts organization south of the City of Chicago and operates through three core pillars:

- The Professional Company, a nationally touring ensemble and resident company at the Harris Theater in Millennium Park, ranked among the 50 largest ballet companies in the United States;
- The School of Ballet 5:8, offering high-caliber pre-professional training and mentorship, with students regularly receiving scholarships to premier programs across the country;
- Community Engagement and Education, including school performances, library partnerships, senior-living outreach, and free or low-cost arts opportunities for families throughout the Southland; and

**WHEREAS**, Ballet 5:8 continues to enrich the cultural landscape of Orland Park by inspiring emerging artists, providing transformative arts experiences for residents of all ages, and strengthening the Village's identity as a growing hub for creativity and culture; and

**WHEREAS**, the Village of Orland Park is proud to recognize Ballet 5:8 for its artistic innovation, educational commitment, and ongoing contributions to the community;
