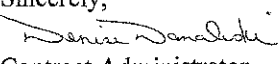
**NOTICE OF AWARD – Addendum A Sidewalk Gap/Path Construction**

**Between**  
*The Village of Orland Park, Illinois ("VILLAGE") and Austin Tyler Construction <sup>Inc</sup> Company*  
**("CONTRACTOR")**  
Austin Tyler Construction Inc.

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. In **SECTION 1: THE CONTRACT DOCUMENTS**, of said Agreement, "Addendum A Sidewalk Gap/Path Construction" shall be added after "Performance and Payment Bonds required by the VILLAGE".
3. In **SECTION 2: SCOPE OF THE WORK AND PAYMENT**, of said Agreement, the words "Addendum A Sidewalk Gap/Path Construction \$ 50,000" shall be added after "Additional pavement patching & infrastructure repairs \$ 215,252.00"; and  
  
the words "TOTAL: an amount not to exceed Two Million Six Hundred Seven Thousand and No/100 (\$2,607,000.00) Dollars" shall be stricken their entirety and replaced with "TOTAL: an amount not to exceed Two Million Six Hundred Fifty-Seven Thousand and No/100 (\$2,657,000.00) Dollars."
4. All of the other terms, covenants, representations and conditions of said Agreement, not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
5. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the **21st day of August, 2014**, shall be attached to and form a part of the Agreement dated the 9<sup>th</sup> day of May, 2014 and shall take effect upon signature below by duly authorized agents of both parties.

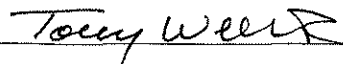
