



**ADDENDUM A TO SCHUSSLER PARK RESTROOM AND STORAGE BUILDING,
DATED APRIL 15TH, 2024,
BETWEEN
THE VILLAGE OF ORLAND PARK AND ROMTEC**

WHEREAS, on April 15, 2024, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as “Village”) and Romtec (hereinafter referred to as “Consultant”) for the performance of certain professional services for the Village in connection with Schussler Park Restroom and Storage Building (hereinafter referred to as the “Project”, the “Work”, or the “Services”) was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify **SCOPE OF WORK, COMPENSATION, AND CONTRACT DOCUMENTS**.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum A and the Agreement, the provisions of this Addendum A shall control.
2. **SECTION 1: SCOPE OF THE WORK** of said Agreement shall be amended to include the “Scope of Work” as set forth in Consultant’s Proposal, dated June 3, 2024.
3. **SECTION 2A: COMPENSATION** in said Agreement shall be amended to strike “a not-to-exceed amount of \$319,056.83” and replace with a new “not-to-exceed amount of \$324,463.89”. Contract was increased by \$5,407.06.
4. **SECTION 3: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum A, dated November 18, 2024: and “Proposal for Work, dated June 3, 2024.”
5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
6. This Addendum A may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum A, made and entered into effective the 18th day of November, 2024, shall be attached to and form a part of the Agreement dated the 15th day of April, 2024 and shall take effect upon signature below by duly authorized agents of both parties.

IN WITNESS WHEREOF, the parties have caused this Addendum A to be executed by their duly authorized officer in quadruplicate counterparts, each of which shall be considered as an original.
