

ADDENDUM A TO TASTE OF ORLAND PARK LIGHTING, SOUND, TRUSS, RIGGING & OTHER STAGE EQUIPMENT DATED MARCH 18, 2024 BETWEEN THE VILLAGE OF ORLAND PARK AND SOUND WORKS PRODUCTIONS DBA VANTAGE PRODUCTION GROUP

WHEREAS, March 18, 2024, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and Sound Works Productions dba Vantage Production Group (hereinafter referred to as "Consultant") for the performance of certain professional services for the Village in connection with Taste of Orland Park Lighting, Sound, Truss, Rigging and Other Stage Equipment (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify SCOPE OF WORK, COMPENSATION and CONTRACT DOCUMENTS.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum A and the Agreement, the provisions of this Addendum A shall control.

SECTION 1: SCOPE OF THE WORK of said Agreement shall be amended to include the "Scope of Work" as set forth in Consultant's Proposal, dated May 21, 2025, due the addition of a stage for use August 1, 2 & 3, 2025 for the Taste of Orland Park, and additional sound and lights required to support the contracted Artists performing on August 2, & 3, 2025 at the Taste of Orland Park.

- SECTION 2A: COMPENSATION in said Agreement shall be amended to explicitly state the budget approved amount of \$32,548 for FY 2025; increase the contract by \$21,300 for a not-to-exceed amount of \$53,848 for FY 2025; plus add a contingency of \$5,000 for FY 2025, which cannot be spent without prior written approval by the Village through a Change Order Request, for a total not to exceed amount of \$58,848 ("Contract Price") for FY 2025; and the Board approved budgeted amount for 2026.
- 3. <u>SECTION 3: THE CONTRACT DOCUMENTS</u> of said Agreement shall be amended to include Addendum A, dated June 2, 2025, for the amended "Proposal for Work", dated May 21, 2025.
- 4. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
- 5. This Addendum A may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum A, made and entered into effective the **2nd day of June 2025**, shall be attached to and form a part of the Agreement dated the 18th of March 2024 and shall take effect upon signature below by duly authorized agents of both parties.
