FINDINGS OF FACT AND RECOMMENDATION

WHEREAS, the Petitioner, [Applicant Name], has submitted an application requesting [type of approval] pursuant to Section 5-101 of the Village of Orland Park Land Development Code (LDC), for the property commonly known as [address] ("Subject Property"); and
