PARISI: Swore in Robert Ortiz, 8133 Deland Court, Tinley Park.

ORTIZ: I am a police officer with the Cook County Sherriff's police department. All of our members are either police officers or fire fighters in Cook County, Olympia Fields, Hickory Hills and the Illinois Department of Corrections. We are all law enforcement. We do fundraisers for injured or fallen firefighters. We just had one May 9th for Tim Jones from Park Forest. We raised \$10,000 for him at that event. In the last 4 years we have donated over \$50,000 to injured or killed police officer's families. That is all I would like to add. We are going to use this space for meetings and storage.

AUBIN: Seeing no one in the public, we will go to our Commissioners.

PARISI: How long has your chapter been in existence?

ORTIZ: Since 2002.

PARISI: You have meetings twice a month?

ORTIZ: We have meetings once a month but events come up where we need to

ORTIZ: Most of our events are held outside so we need to store the pop up tents. All of the donations that we get, we give back to the people that we donated to. We sell t-shirts to people that support us to gain money for things that the chapter needs so we are not taking it out of the donation account.

ORTIZ: No, we do not have any fundraisers at the building at all.
