**ADDENDUM #1 TO EXHIBIT B - VOP MUNICIPAL BASIN PHASE I, DATED MARCH 31, 2023,
BETWEEN
THE VILLAGE OF ORLAND PARK AND DAVEY RESOURCE GROUP**

WHEREAS, on March 31, 2023, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and Davey Resource Group (hereinafter referred to as "Consultant") for the performance of certain professional services for the Village in connection with Exhibit B - VOP Municipal Basin Phase I (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify EXHIBIT B: SCOPE OF WORK, COMPENSATION, and CONTRACT DOCUMENTS.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum #1 and the Agreement, the provisions of this Addendum #1 shall control.
2. **SCOPE OF THE WORK** of said Agreement shall be amended to replace the "Exhibit B dated March 31, 2023" and include a revised "Exhibit B dated October 10, 2024" which reflects an increase of \$4,350.00, for a new total not-to-exceed amount of \$166,240.00.
3. **COMPENSATION** in said Agreement shall be amended to strike the original contract amount of \$161,890.00, and replaced with a new total not-to-exceed amount of \$166,240.00.
4. **THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum #1, dated November 4, 2024; and "Exhibit B dated October 10, 2024."
5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
6. This Addendum #1 may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum #1, made and entered into effective the **4th day of November, 2024**, shall be attached to and form a part of the Agreement dated the 31st of March, 2023, and shall take effect upon signature below by duly authorized agents of both parties.

IN WITNESS WHEREOF, the parties have caused this Addendum #1 to be executed by their duly authorized officer in quadruplicate counterparts, each of which shall be considered as an original.
