Dear Mr. Ingram,

McDonough Associates has reviewed the 10 bids received by the Village of Orland Park on Wednesday May 25, 2011 for the above referenced project. Our engineer's estimate of cost based upon recent previous bid prices was \$208,580.00. The bids ranged from \$181,090.00 to \$381,000.00. The lowest total bid based upon bid quantities and the unit prices submitted by Airy's Incorporated, 7455 W. Duvan Drive, Tinley Park, IL 60477, is \$181,090.00.

We are very familiar with the work of Airy's in Orland Park and other locations. They have recently performed work with us at the Somerset Manorhomes project in Orland Park. Airy's has performed numerous construction projects in Orland Park and with McDonough Associates Incorporated. Based upon the knowledge we have of Airy's work, we recommend the acceptance of the Airy's bid by the Village and further recommend the Village award this Contract to Airy's Inc. If the Village Board approves the bid award at the next Town Board Meeting, we will then draft the Notice of Award to Airy's and deliver this document, with the Village delivery of the Contract and Contract Bond forms to the Contractor for their execution.

We have included a copy of the engineer's estimate and the bid tabulation that we developed and used as a check on the bid totals. We are returning to the Village with this letter the copy of the bid submittals given to us for review. The Clerk's office has confirmed that a Bid Bond and signed Addendum, which we did not have, were submitted by Airy's.
