WHEREAS, on May 23, 2017, a certain Agreement regarding 2017 Roadway, Parking Lot, Multi-Use Path Asphalt Pavement Maintenance between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to increase the SCOPE OF WORK;

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

- 1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
- SECTION 1: THE CONTRACT DOCUMENTS of said Agreement shall be amended to include "Addendum A dated October 16, 2017"
- 3. <u>SECTION 2: SCOPE OF THE WORK AND PAYMENT</u> of said Agreement shall be amended to strike the following in its entirety:

And replace it with the following in its entirety:

TOTAL: an amount not to exceed Six Hundred Fifty Thousand and No/100 (\$650,000.00) Dollars (bid amount of \$458,320.00 + contingency for additional work + additional funds per Addendum A) based on proposed unit prices

- 4. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
- 5. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.
